It is information of all concerned that, the following changes have been made to the guidelines regarding inclusion of registration for PM Internship by the students pursuing full time final year UG Course

as per OM dt-08.04.2026 PMIS Cell, Ministry of Corporate Affairs, Government of India, it is stated that the final year students of Graduate courses are eligible to apply for internship under PMIS Pilot Project subject to the following conditions, as decided in consultation with the Department of Higher Education, Ministry of Education:

- i. Meet the eligibility criteria(Ref. Notice no.57/dt-09.04.2026 of the undersigned)
- ii. The applicant should submit a No Objection Certificate (NOC) from the respective Educational Institution during the *application* process. The NOC must affirm that the institution has no objection to participation of the student in the pilot project of the Prime Minister Internship Scheme and that academic requirements will not be impeded thereby. The NOC must be submitted in the format attached as Annexure. 1


